IT'S POOL SEASON AGAIN!

Please complete the attached request for swimming pool passes and Resident Information Sheet and return both to the Management Office by fax, 703-920-2534, or at the AV Condo Office at the address listed below, by **close of business, Thursday, May 15, 2008**. Any request submitted after that date will be *required to pay a \$20.00 late charge*. **THERE WILL BE NO EXCEPTIONS! The information sheet must be filled out completely, and must include the number of the storage bin you are using, or no passes will be issued.** Please do not write that nothing has changed, or that it is the same as last year. **Also, you must check the appropriate box on the Pool Pass Request Form advising the Management Office that you do/don't have a current copy of the Arlington Village Rules, Regulations and Policies, dated January 1, 1997.**

Pool passes will be issued to bonafide occupants of each unit. Pool passes will not be issued to both owners and tenants of the unit. Only two (2) adult passes will be issued per unit unless each additional resident can verify residency with the Management Office.

NO PASSES WILL BE ISSUED unless all the following information is current:

- (1) Settlement Sheet or Deed (Article VIII, Section 1)
- (2) Leases on file (Article V., Section 8)
- (3) Key on file (Right of Access, Section 9)
- (4) Owner/Resident Information Sheet completed
- (5) Condo fees and in-house maintenance charges are up-to-date.

Please respond promptly in order that your pool pass may be issued before pool season begins. If you are unsure of the status of your file, please call the Office at 703/920-1000 to verify.

The pool will open for the year 2008 on Saturday, May 24th and closes on Labor Day, September 1st. However, the pool will be open two additional weekends, (September 8/9 and September 13/14) weather permitting.

The Pool will close for humans at 5:00 PM on Sunday, September 14, 2008, to allow Arlington Village to hold the 2nd Village Dog Swim between 5:30 PM and 7:30 PM.

Daily guest pool passes will be available at the gate for \$7.00 a day, payable by check only. Multi-Use Passes are available from the Management Office for \$50.00 for 10 entries into the pool... The pool hours are as follows:

Monday (all season)	4:00 p.m. - 9:00 p.m.
Tuesday to Friday	12:00 p.m. - 9:00 p.m.
Saturday, Sunday & Holidays	10:00 a.m. - 8:00 p.m.

The convivial atmosphere of the Village and the proper observance of the pool rules and regulations should result in an excellent pool season.
